During the period November 30 through December 31, 1970, sources, who have furnished reliable information in the past and are familiar with Chinese individuals in the Amherst, Massachusetts, area, particularly those connected with the University of Massachusetts, Amherst College and Hampshire College (all located at Amherst, Massachusetts) advised that they did not know a [Dora Tong, a Mr. Tong or a Tang Ying-shen.] (S) These sources advised that they could identify no such persons, or persons with similar names, who were associated with any of the aforementioned educational institutions, either as students or faculty members.
