Referenced letter indicates that two calls had been made during 1972 from Miami, Florida and charged to subject's telephone at New York. These calls were to Ventura, California, number (805) 643-7640.

CSLA 6679-S advised that this phone number is listed to Ventura Furniture Mart, 394 Main Street, Ventura, California. The billing is to EDWARD GREENFELD, at the same address.

The files of the Ventura Credit Breau were reviewed by SA VINCENT J. O'NETLL on 1/30/73. These files indicated that as of 1967, EDWARD GREENFELD and his wife, ANNA, resided at 49 Hillview Avenue, Ventura, California. He was about 65 years of age, had been in the area since 1946 and was self-employed as the owner of the Ventura Furniture Mart A 1946 report stated that he and his wife had two children and had formerly resided at 539 Barretto Street, and at 1183 Garrison Avenue, Bronx, New York. The files contained an article from a Ventura newspaper dated in 1967 which contained GREENFELD's picture and stated he had retired in 1966 afterwhich he had taken a 12-month vacation abroad. Upon his return he opened hss current business. During his trip he had visited Israel, Rome, Florence, Paris, and London.
