Re NY letter dated 7/25/61 in captioned subject matter; Baltimore airtel to Director with copy to NY, dated 8/15/61, captioned "DICK AND SUSAN (LNU), 110 CHRISTOPHER STREET, NEW YORK CITY, NEW YORK; IS - C, OO:NEW YORK"; and memo of SA ROBERT C. NORTON to SAC, Baltimore dated 9/5/61, with copies to NY files "DICK (LNU), 110 Christopher Street" and "SUSAN (LNU), 110 Christopher Street".

CSNY LENORE SERKANIC (conceal) advised SA PAUL A. JOENSEN on 10/9/61, that both captioned subjects are apparently not regularly employed inasmuch as she has observed them in the vicinity of their residence at 110 Christopher St., NYC, on a regular basis since their return to the above address on 6/10/61.

Copies are being submitted to the Baltimore Office for information only since the descriptions of captioned subjects, their residence address and the fact of their previous travel in China as furnished by BA 975-S, are obviously identical to the subjects.

An FD-122 noting the employment of SUSAN HEILIGMAN FRANK as unemployed has been prepared.

No further investigation is contemplated by the NYO and the cases are being placed in a Closed status.
