- 2) Will obtain above-described typewriter and again submit appropriate specimens to the FBI Laboratory for comparison with extortion letters in this case.
- 3) Will also attempt to obtain, with consent of the operators of the Abbey Clinic, specimens from a fifth typewriter, a Royal, which has not previously been examined.
- 4) Following results of FBI Laboratory examination of specimens obtained from above-described typewriters, will consult USA relative to prosecution. (It is to be noted that by report dated 2-16-65, the FBI Laboratory identified specimens taken from above-mentioned Underwood typewriter as being identical to Q3 and Q4, which consist of an envelope and letter sent to victim MENDOZA by the extortioner in this case).
- 5) Will, at a logical time, thoroughly interview all subjects and suspects in this case for the purpose of attempting to obtain confessions, admissions, and other evidence.
- 6) Will continue efforts to obtain evidence concerning the source of the materials used in manufacturing the bombs and incendiary devices used by the extortioners in this case.
- 7) Will attempt to locate a second typewriter which has been used in writing one or more of the extortion letters in this case.
- 8) Will maintain close liaison with the Miami Beach, Coral Gables, and Fort Lauderdale Police Departments and the Dade County Sheriff's Office.

ADMINISTRATIVE

On January 15, 1965, MM 635-S went to the Abbey Clinic, 5190 S. W. 8th Street, for a medical consultation with Dr. ORLANDO BOSCH. MM 635-S was accompanied by his son, who was examined by Dr. BOSCH. At the conclusion of this examination, Dr. BOSCH wrote a prescription on an Underwood typewriter which was located in the office occupied by BOSCH.

In view of the circumstances under which specimens from this Underwood were obtained through the cooperation of Mr. NENGEL, the results have been recorded on the cover pages of this report and efforts are now underway to obtain possession legally of this typewriter.

On February 19, 1965, Mr. AARON A. FOOSANER, AUSA, Miami, was consulted. Mr. FOOSANER, who was then leaving his office for an appointment, stated he would like to further consider this matter before authorizing issuance of a search warrant inasmuch as the circumstances were somewhat unusual.

On February 9, 1965, MM 635-S again returned to the Abbey Clinic for medical examination by BOSCH. He noticed that BOSCH maintained at his desk an address book and a collection of personal papers, which he was unable to examine. (X)(u)

For the information of the Bureau, on the week-end of January 15, 16, and 17, 1965, a discreet surveillance was conducted in the neighborhoods of BOSCH and GARCIGA for the purpose of ascertaining if either of these suspects made any telephone calls from public booths or went to the Ft. Lauderdale area where it was contemplated contact might be made by them with IGLESIAS. Results were negative.

EVELIO ALPIZAR PEREZ, Key Source-Cuban:

During the latter part of 1963 and continuing through 1964, he was in close contact with Dr. ORLANDO BOSCH AVILA, head of the NIRR, and several other members of that organization. BOSCH had utilized the services of this individual, a Cuban exile pilot, in connection with various plans of BOSCH to stage raids against the CASTRO government in Cuba. In about May, 1964, BOSCH's organization was in the process of manufacturing a torpedo which was to be used in attacking some vessel carrying supplies to Cuba. (X)(u)

He recalled that at about this same time, he was at the home of LAREDO RODRIGUEZ, a member of the NIRR. BOSCH and LUIS BERTOT, the latter also being a member of the same organization, were also present. He recalled that BOSCH was very angry because he had just been to the office of ALBERTO VADIA, where he expected to have an appointment with VADIA in order to obtain a contribution of several thousand dollars, possibly between two and five thousand dollars. When BOSCH arrived at VADIA's office, he was handed only \$150.00 by VADIA's secretary and he was not given the opportunity of seeing VADIA. BOSCH, in recounting this incident to source and the others present, declared that VADIA was an "s.o.b.," along with the other rich Cubans, and that the NIRR should place a bomb at the home of every Cuban millionaire in Miami and blow them up, as an example to the other wealthy Cubans. At this point source, who is by present employment an air conditioning repairman, suggested that any such bombs be placed in the air conditioning units of such people. BOSCH seemed to be immediately interested by this idea and questioned source as to how this could be done. He told BOSCH that a bomb could be placed in the air conditioning unit in such a fashion that when the button is pressed to start the unit, the bomb would explode. (X)(u)

Source made the above observation after he was allowed to read a copy of the extortion letter which was (X)(u)
