IN THE ABOVE TELEPHONE CALL, FRANK CASTRO SAID THAT CORU SHOULD DELAY ANY NEWS RELEASE REGARDING THIS AIRPLANE INCIDENT, UNTIL THEY ARE ABLE TO DETERMINE PUBLIC REACTION TO THIS INCIDENT. ~~(u)~~

SOURCE IS PLACED IN A CUBAN ANTI-CASTRO GROUP, AND HE CONTINUES TO FURNISH VALUABLE INFORMATION. THEREFORE, NO ACTION SHOULD BE TAKEN WHICH COULD COMPROMISE THIS SOURCE. ~~(u)~~

AS FURTHER INFORMATION ON THIS MATTER, ON OCTOBER 6, 1976, SOURCE ADVISED THAT RAFAEL PEREZ DORESTE TOLD SOURCE THAT SECUNDINO CARRERA TELEPHONED PEREZ DORESTE ON OCTOBER 6, 1976, SAYING HE WANTED TO TALK TO THE BOYS IN MIAMI AND THAT CARRERA WOULD BE FLYING TO MIAMI IN THE VERY NEAR FUTURE. CARRERA ALSO TOLD PEREZ DORESTE THAT OSCAR ANGULO WILL PROBABLY HAVE TO FLY TO SANTO DOMINGO, DOMINICAN REPUBLIC, ON SUNDAY, OCTOBER 10, 1976, FOR A TALK WITH FRANK ~~(u)~~

PEREZ DORESTE TOLD SOURCE THAT IN THIS TELEPHONIC CONVERSATION, CARRERA ALSO INDICATED THAT REINOL RODRIGUEZ PLACED A BOMB AT A TV STATION IN PUERTO RICO A COUPLE OF DAYS AGO. THIS BOMB WAS PLACED THERE BECAUSE A MOVIE DOCUMENTARY ABOUT CUBA WAS BEING SHOWN ON THIS TV CHANNEL. X(u)

SOURCE ADVISED THE EVENING OF OCTOBER 6, 1976, THAT BEBO ACOSTA HAD JUST TOLD SOURCE THAT REINOL RODRIGUEZ HAD JUST TELEPHONED ACOSTA FROM PUERTO RICO SAYING THAT THEIR GROUP (REFERRING TO CORU) WAS INVOLVED IN THE BOMBING OF THE CUBANA AIRLINES AIRPLANE WHICH CRASHED SHORTLY AFTER TAKEOFF FROM BARBADOS ON OCTOBER 6, 1976. RODRIGUEZ TOLD ACOSTA THAT THERE SHOULD BE NO PUBLICITY REGARDING THIS BOMB AT THIS TIME INASMUCH AS THE PEOPLE INVOLVED WERE "STILL INSIDE". SOURCE SAID THIS APPARENTLY MEANS THAT THE PEOPLE INVOLVED IN THE BOMBING WERE APPARENTLY STILL IN BARBADOS. X(u)

SOURCE SAID THAT ON OCTOBER 7, 1976, VARIOUS FLNC MEMBERS WERE DISCUSSING THIS AIRPLANE CRASH AND DURING THIS X(u)
