For the information of Portland, referenced report indicated that a 1969 Caveman Motor Lodge and a 1969 Ford pickup truck, VIN P40CLES90999, were stolen Grants Pass, Oregon, July 21, 1969. Original report re this matter designated 1969 Ford pickup truck with above VIN as vehicle number 9. Hereafter the 1969 Caveman Motor Lodge will be designated vehicle number 10.

Handwriting examinations of Alabama registrations are not being requested at this time due to the fact that the only submissible document containing pertinent handwriting would be a copy of the third copy of the registration papers.

On January 28, 1971, PCI LEROY JACKSON advised that he had been unable to determine any information concerning a 1969 green Chevrolet long wheel base pickup truck supposedly in the possession of E. P. WILLIAMS.

On February 8, 1971, PCI LEROY JACKSON advised that an individual whose name is unknown to him did live in an apartment at the Catfish Cove during the time E. P. WILLIAMS was supposed to be in possession of this truck. Although he does not know this individual's name, he does know that he was previously employed by GRIFFIN Chevrolet Company, El Dorado, Arkansas, and has recently moved to Crossett, Arkansas. He believes that this individual may be able to furnish some information concerning the pickup truck.
