On 9/15/58, LR 474-S made available personal records of Imperial Grand Dragon ROY E. DAVIS of captioned organization of Dallas, Texas. Among these papers was what appeared to be a new address book containing handwritten names of what appeared to be members of his organization in Arkansas and Texas.

Enclosed herewith to the Bureau are two Photostats of the list of names in the address book and one Photostat of the list is being furnished the Dallas Office.

The following has been noted from an examination of the enclosed list:

The first listing on Page 1 is "Mother's League, LO 5-4631," which is the telephone number of Goodman Fireworks Company, Little Rock, the place of employment of Mrs. MARGARET JACKSON, President of the Mothers League of Central High, Little Rock. ARK.

All of the individuals listed at Little Rock are known to be members of the captioned organization at Little Rock with the exception of J. R. ENGLISH on Page 3, who has paid his initiation fee but has not been sworn in, to the knowledge of LR 474-S.

WM. W. HAYNES listed on Page 4 resides in North Little Rock, Arkansas, and is a member of the Klan.

J. R. BEARDEN listed on Page 2 is former
