Reference San Juan teletype to the Bureau dated 6/21/74, and Bureau teletype to San Juan dated 6/27/74.

Captioned source is being closed on this communication. Source has been cooperative in providing information available to him regarding Cuban exile matters, particularly of the Partido Revolucionario del Pueblo (Revolutionary Party of the People) (PRP), of which source was a founder. In in-depth interview, source has expressed disillusionment with Cuban exile activities, particularly since the demise of the PRP. Source has advised he will provide information available to him, but does not desire to become active in Cuban exile matters. Source advised that for the past two years his activities had been directed at his business of engineering. The majority of source's time is spent in Jamaica on pre-fabricated housing construction. San Juan will continue contacts with source only on leads on which he may have information, but will not continue to contact source on a regular basis.

Because of source's inactivity and no intentions toward activity in Cuban exile matters, San Juan will not continue further development of source as PSI at the present time.
