LA 4350-C was interviewed on 3/28/62. He stated he obtained his information through his various contacts over the years, and that he is unable to furnish evidentiary data or leads which could develop proof of the type desired.

Informant said he has heard that CHAVEZ has been indicted in Puerto Rico on some felony charges, details of which he does not know, and that as a result CHAVEZ may be losing his importance in union matters in that area.

Because the informant is not in a position to furnish additional data even though he is convinced his original data is an accurate analysis of the situation which has existed, this matter is being closed. If the informant at a later date does obtain data which can be used, it will be forwarded to the Bureau.
