ReNYlet 11/9/64, in which WFO was requested to canvass logical sources to determine if subject became known to them while in the Washington, D. C., area.

On 12/14/64, JOHN MOESON, 2611 Loma Street, Silver Spring, Maryland, (WFO source of information, who requested his name be protected and who has furnished reliable info in the past) advised SA CHARLES B. FINDLEY, JR. that he does not know the subject and had never heard of him.

Source did recall, however, that he had heard of a man from New York City, a non-Chinese, who has in the past visited S. C. LING, Manager of The Shanghai Restaurant, 1201 Fioler Lane, Silver Spring, Maryland. This man is reportedly pro-Chinese communist.

According to the source LING is a former employee of the New York "China Daily News," declared by the source as a Chinese communist newspaper. His true name is LEE Chu or Chu LEE and he came to the Silver Spring, Maryland, area several years ago.

The source further stated that the only additional information he could learn about the man from New York is that he is reportedly from the lower part of Manhattan, near the New York Chinatown area. It is not known if this individual is identical with the subject.
