With reference to Bureau letter to Los Angeles dated 6/24/64, the title of this communication is marked changed to record the name LORENZO PASCILLIO which was reported by Mr. JOSE NORMAN on 8/19/64, as a name by which LORAN HALL was known in Los Angeles.

Enclosed to the Bureau are nine copies and to Miami and Dallas one copy each for information of a confidential letterhead memorandum dated and captioned as this communication. Confidential classification assigned as data reported in memorandum contains information emanating from a confidential source and technique whose value in Bureau investigations is continuous and whose disclosure would hamper Bureau investigative interests.

A copy of letterhead memorandum is being directed to Secret Service locally per Bureau letter of reference 6/24/64.

The concealed source supplying information on 8/4/64, is Mr. HYMAN KENSBURSKI, established source at the United States Postmaster's Office, Los Angeles, who determined forwarding data from the Post Office at Monterey Park, California (concealment deemed advisable).

The logical source named in the enclosed letterhead memorandum is identified as CSLA 3148-S, contacted on 8/18/64, by SA CHARLES M. PAGE.
