Re Miami letter and LHM dated 8/5/66 and San Juan letter dated 11/29/66.

*On 11/24/66, Miami sources knowledgeable in Cuban exile matters, namely MM 492-S, MM 635-S, MM 639-S, and CARLOS ZARRAGA MARTINEZ, Key Source - Cuba, were contacted by SA ROBERT J. DWYER and they advised that no recent information had come to their attention that JURE was actively engaged in a plan for the assassination of FIDEL CASTRO.

On 12/9/66, OSORIO DAVILA, leading JURE officer at Miami, Florida, advised that until recently the Directorate of JURE consisted of MANUEL RAY in Puerto Rico, ORLANDO CASTRO in Venezuela, and DAVILA in Miami. In order to form a quorum for JURE decisions on a convenient basis, two additional members have been added to the Directorate in Puerto Rico. These are ARTURO VILLAR and EMILIO GUEDES.

Mr. DAVILA advised that JURE at Miami is relatively inactive and he, himself, has obtained employment as a new car salesman at Dumas Milner Chevrolet in Miami. He stated that JURE has always maintained the position that CASTRO's overthrow must be accomplished from inside Cuba and for this reason MANUEL RAY, leader of JURE, and the JURE organization have continued to seek contacts within Cuba which at some future time could furnish an opportunity to take action against the CASTRO regime. He stated that JURE continues
