OPERATIONS AND BY USING THE OLD NAME OF JURE THEY FELT THAT THEIR NEW OPERATION MIGHT POSSIBLY BE JEOPARDIZED. NUNEZ ADVISED SOURCE THAT HE WILL BE TRAVELING TO COSTA RICA TO ATTEND THE OPERATIONAL MEETINGS OF THE COMITE AND THAT THE PRESIDENT OF COSTA RICA IS FINANCING THE TRIP AND THE OPERATIONS OF THE NEW COMITE.

SOURCE DESCRIBED CAPTIONED ORGANIZATION AS BEING COMPOSED OF DEMOCRATIC LEFTISTS WHICH HE DESCRIBED AS PEOPLE VEHEMENTLY OPPOSED TO CASTRO BUT INCLINED TOWARDS A DEMOCRATIC SOCIALIST GOVERNMENT, WHICH THEY HOPED TO ESTABLISH UPON THEIR RETURN TO CUBA. THEIR FIRST ITEM OF BUSINESS WILL BE THE OVERTHROW OF CASTRO, POSSIBLY USING COSTA RICA AS A BASE OF OPERATIONS.

LEAD. SAN JUAN AT SAN JUAN, PUERTO RICO. WILL MAINTAIN CONTACT WITH SJ FOUR NINE TWO AND CONTINUE EFFORTS TO OBTAIN ADDITIONAL INFORMATION REGARDING CAPTIONED ORGANIZATION AND ITS MEMBERS.
