NOVO was contacted originally in this matter on 8/8/60, incidental to an article by SAM POPE BREWER which appeared in the "New York Times" newspaper of 8/8/60. The article contains the results of an interview between NOVO SAMPOL and BREWER incidental to a meeting held at the Belmont Plaza Hotel in NYC, on 8/7/60, which was an attempt to unify the various anti-CASTRO forces in the NY metropolitan area.

On 8/9/60, NOVO SAMPOL furnished SA VINCENT J. WARGER with a list of the members elected at this meeting on 8/7/60, which members make up a 12 man board.

NY will continue to be alert to developments of this organization.

Copies are being designated for the Tampa Office inasmuch as there is a branch of the CNA there.
