Re Miami letter and LHM to the Bureau, 1/30/74.

On March 15, 1974, MM 1337-S advised that the ASI and the JCR appear to be relatively dormant at the present time. He advised that CONRADO RODRIGUEZ SANCHEZ, head of the ASI and a Director of JCR, is circulating around Dr. MANOLO REYES of Miami who has aspirations of becoming President of a Cuban government in exile, however, REYES has been unable to build up a following of any significant proportion.

It has been previously reported that action members of the ASI, ABDALA and the Golden Falcons have joined together to form a small terrorist organization known as the Frente de Liberacion Nacional (FLNC) which claims credit for a number of attacks against Cuban fishing boats, the bombing of the "Mereghan II" and two bombing attacks against the Cuban Embassy in Mexico City during the past few months. However, investigation to date has failed to reflect the identity of any member of the ASI who is specifically involved in these activities.

Miami will continue to investigate the ASI and the JRC for any future pertinent developments.

Previous investigation has reflected that CONRADO RODRIGUEZ SANCHEZ, a Cuban exile and former labor leader, represents the ASI and JCR in Miami. The ASI is the labor group of the JCR. Both are anti-CASTRO exile groups with membership in Miami and in the New York - New Jersey areas. In August 1973, it was reported that RODRIGUEZ disclosed that the ASI and JCR had agreed secretly with these other groups in New York City to carry out attacks in that city.

CURRENT DEVELOPMENTS

On October 4, 1973, information was reported that two Cuban fishing boats were attacked off the north coast of Cuba. A Havana radio broadcast identified these boats at the "Cayo Largo 17" and the "Cayo Largo 34."

On October 5, 1973, MM T-1, who is acquainted with some members of the ASI, advised as follows:

FRANK CASTRO of the Halcones Falcones (Golden Falcons) directed the attack and CONRADO RODRIGUEZ SANCHEZ received

news of the attack by radio from the attackers. RODRIGUEZ keeps his radio set in a small truck to avoid detection. RODRIGUEZ disclosed that the Cuban fishermen had been taken prisoners, with the exception of one who was killed, and that the prisoners would be abandoned on a key in the Bahamas. FRANK CASTRO and two members of ABDALA, RUBEN DARIO and GUSTAVO MARIN, were scheduled to return to Miami on a speedboat.

On the same day, October 5, MM T-1 received information from a source close to FRANK CASTRO, that the attack was a joint operation of the Golden Falcons, ABDALA, and the ASI, and that members of each participated in the attack.

ABDALA and the Golden Falcons (a sky diving club headed by FRANK CASTRO) are anti-CASTRO groups.

FRANK CASTRO, RUBEN DARIO, also known as Ruben Dario Lopez, and GUSTAVO MARIN, denied involvement in the attack when interviewed in connection with an investigation concerning the alleged October 4 attack.
