SUBJECT: ANTI-CASTRO ACTIVITIES  
IS - CUBA

ReNYtel, 10/22/74, captioned as above; MMairtal dated 8/30/73 bearing double caption "ACCION SINDICAL INDEPENDIENTE (ASI); INDEPENDENT LABOR ACTION; IS - CUBA, JUNTA CUBANA REVOLUCIONARIA (JCR), CUBAN REVOLUTIONARY BOARD; IS - CUBA".

ReNYtel reported that HORACIO MINGUILLON, head of Comandos Libres Nacionalistas (CLN), is contemplating approaching JOSE PEREZ-LINARES of the ASI to enlist his aid in obtaining explosives.

This information appears to dovetail with information set forth on page 1 of the LHM attached to referenced MM airtel, a copy of which was designated for Newark. Specifically, the referenced MM communication reported that a leading figure in the ASI had disclosed that a secret agreement had been negotiated between the ASI and 3 other action groups in New York City to coordinate attacks in NYC in the future.

It would appear from the information in re NYtel that MINGUILLON's group, the CLN, is one of the 3 action groups that are party to the aforementioned secret agreement with the ASI. The other two groups are probably the Cuban Nationalist Movement and Abdala. Moreover, it is noted that the ASI and Abdala are headquartered on the same floor in the same building in NYC.
