THE BUREAU SHOULD ALSO NOTE THAT WHEN OTERO BECAME A FUGITIVE FROM THE U.S., AFTER BEING CHARGED WITH THE NINE BOMBINGS OF 1975, MORALES HAD HIM GO TO VENEZUELA WHERE OTERO WAS THEN USED AS AN AGENT OF THE VENEZUELAN GOVERNMENT AND SENT TO CHILE TO OBTAIN INFORMATION REGARDING CHILEAN INTELLIGENCE IN VENEZUELA. *X(u)*
