[LEE TATE,] CIA COVERT, MIAMI, FLORIDA (PROTECT), ADVISED IN LATE AFTERNOON OF MAY 11, 1965, THAT FROM A RELIABLE SOURCE, IT WAS LEARNED ORLANDO BOSCH AVILA, HEAD OF MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA, (MNPR), PLANS TO ATTEND AND CREATE DISORDER AT THE "TEACHIN" BEING SPONSORED BY THE STUDENTS FOR A DEMOCRATIC SOCIETY AND SCHEDULED TO TAKE PLACE ON THE CAMPUS OF THE UNIVERSITY OF MIAMI, CORAL GABLES, FLORIDA, MAY 11, 1965.

SGT. JOSEPH FERNANDEZ, CRIMINAL INTELLIGENCE SECTION DADE COUNTY SO, DADE COUNTY, FLORIDA, FURNISHED SUBSTANTIALLY THE SAME INFORMATION ON THE LATE AFTERNOON OF MAY 11, 1965.

ORLANDO BOSCH, HEAD OF MIRR, (BUFILE 97-4474), AN ANTI CASTRO CUBAN REVOLUTIONARY ACTION GROUP, IS ALSO SUBJECT OF CASE ENTITLED, "ORLANDO BOSCH AVILA, AKA; ET AL; JULIO CESAR IGLÉSÍAS; ET AL-VICTIMS; EXTORTION; (BUFILE 9-42758)," IN WHICH BOMBS HAVE BEEN USED.

MM 635-S ADVISED LATE NIGHT OF MAY 10, 1965, THAT ORLANDO BOSCH IS KNOWN TO POSSESS NECESSARY INGREDIENTS FOR MAKING BOMBS.

DADE COUNTY SO IS AWARE THAT ORLANDO BOSCH WAS A SUSPECT IN BUREAU EXTORTION CASE WHERE BOMBS WERE USED.

CORAL GABLES P.D. WAS ADVISED MORNING OF MAY 11, 1965, THAT ORLANDO BOSCH HAD INGREDIENTS FOR MAKING BOMB AS HE IS A SUSPECT IN AN EXTORTION CASE OF THAT AGENCY. ASSISTANT CHIEF OF POLICE DELL EDWARDS, CORAL GABLES P. D. ADVISED 6:15 P. M., MAY 11, 1965.
