RE MIAMI AIRTEL TO BUREAU, JUNE 15, 1965.

AT 11 PM, JUNE 21, TELEVISION CHANNEL TEN, MIAMI, NEWS RELEASE SHOWED ORLANDO BOSCH AVILA, COORDINATOR GENERAL OF MIRR, HOLDING PRESS CONFERENCE AT MIRR OFFICE. BOSCH EXHIBITED A SMALL MICROPHONE AND POINTED TO AN ELECTRICAL OUTLET IN HIS OFFICE WHERE HE CLAIMED TO HAVE DISCOVERED THE MICROPHONE CONCEALED. BOSCH REMARKED THAT HE HAD NEVER BELIEVED THAT ANYTHING LIKE THIS COULD HAPPEN IN THE U.S., BUT ONLY IN A COMMUNIST COUNTRY. WHEN QUESTIONED BY TELEVISION MAN AS TO WHOM HE BELIEVED RESPONSIBLE FOR THIS MICROPHONE, BOSCH REPLIED THAT HE HAD CONTACTED SOME ELECTRONICS EXPERTS AND HAD BEEN TOLD THAT ONLY SOME AGENCY OF THE U.S. GOVERNMENT WOULD USE SUCH AN ELABORATE DEVICE. BOSCH DID NOT NAME ANY PARTICULAR AGENCY. (IT IS NOT OURS)

MIAMI 635-S AND MIAMI 815-S WHO WERE IN ATTENDANCE, STATED THAT BOSCH'S PRESS CONFERENCE TOOK PLACE AT THE MIRR OFFICE, 1661 WEST FLAGLER ST., MIAMI. BOSCH TOLD MIAMI 815-S THAT HE BELIEVES CIA WAS RESPONSIBLE. (2)

MARCELLINO GARCIA, MIRR OFFICIAL, CONFIDED TO MIAMI 635-S THAT HE BELIEVED THE FBI WAS RESPONSIBLE. BOSCH CLAIMED TO

HAVE DISCOVERED THIS MICROPHONE ON JUNE 19 LAST.

BOTH INFORMANTS ADVISED THAT BOSCH ALSO SHOWED A MOVING PICTURE OF A CUBAN BOAT, THE "ARACELIO IGLESIAS," WHICH COLLIDED WITH A NORWEGIAN VESSEL, THE "NIDAREID" ON JUNE 11 LAST, NEAR THE PANAMA CANAL. BOSCH CLAIMED THAT HIS ORGANIZATION HAD MOVED A BUOY AND CHANGED OR CONCEALED CERTAIN MARINE LIGHTS IN AN EFFORT TO FORCE THE CUBAN VESSEL TO RUN AGROUND AS IT WAS TRANSPORTING A LOAD OF CUBAN SUGAR TO TOKYO. BOSCH CLAIMED HIS ORGANIZATION WAS RESPONSIBLE FOR THE COLLISION.

ON MORNING OF JUNE 22, ^{MIAMI} [815] S^W ADVISED THAT CUBAN RADIO PROGRAMS, MIAMI, ANNOUNCED THAT BOSCH PLANNED TO MAKE PROTESTS TO THE PRESIDENT OF THE U.S., AND TO THE U.S. GOVERNMENT IN WASHINGTON WITH REGARD TO THE MICROPHONE INCIDENT DESCRIBED ABOVE.

MIAMI POSSESSES NO INFORMATION CONCERNING INDIVIDUAL OR AGENCY RESPONSIBLE FOR ALLEGED MICROPHONE INCIDENT, BUT CONSIDERS IT POSSIBLE THAT BOSCH HIMSELF MAY HAVE PLANTED THIS DEVICE FOR PROPAGANDA PURPOSES.

RE MIAMI AIRTEL TO BUREAU, JUNE 15, 1965.

AT 11 PM, JUNE 21, TELEVISION CHANNEL TEN, MIAMI, NEWS RELEASE SHOWED ORLANDO BOSCH AVILA, COORDINATOR GENERAL OF MIRR, HOLDING PRESS CONFERENCE AT MIRR OFFICE. BOSCH EXHIBITED A SMALL MICROPHONE AND POINTED TO AN ELECTRICAL OUTLET IN HIS OFFICE WHERE HE CLAIMED TO HAVE DISCOVERED THE MICROPHONE CONCEALED. BOSCH REMARKED THAT HE HAD NEVER BELIEVED THAT ANYTHING LIKE THIS COULD HAPPEN IN THE U.S., BUT ONLY IN A COMMUNIST COUNTRY. WHEN QUESTIONED BY TELEVISION MAN AS TO WHOM HE BELIEVED RESPONSIBLE FOR THIS MICROPHONE, BOSCH REPLIED THAT HE HAD CONTACTED SOME ELECTRONICS EXPERTS AND HAD BEEN TOLD THAT ONLY SOME AGENCY OF THE U.S. GOVERNMENT WOULD USE SUCH AN ELABORATE DEVICE. BOSCH DID NOT NAME ANY PARTICULAR AGENCY.

MM 635-S AND MM [815-S] WHO WERE IN ATTENDANCE, STATED THAT BOSCH'S PRESS CONFERENCE TOOK PLACE AT THE MIRR OFFICE, 1661 WEST FLAGLER ST., MIAMI.

BOSCH TOLD MM [815-S] THAT HE BELIEVES CIA WAS RESPONSIBLE. (K)

MARCELLINO GARCIA, MIRR OFFICIAL, CONFIDED TO MM635-S THAT HE BELIEVED THE FBI WAS RESPONSIBLE. BOSCH CLAIMED TO
