The Miami Office has not interviewed MIKE RAFFERTY or MELVIN HAYES, as requested by the Department of Justice, because previous investigation has reflected that RAFFERTY and HAYES are relatively newcomers and their contact with BOSCH has been largely through BILL JOHNSON, who has been interviewed.

A review of the entire file in this case, dating back over a period of several years, fails to reflect that either BOSCH or the MIRR has a foreign principal inside Cuba or any other foreign country. The MIRR has no leadership, no organization, and no representation inside Cuba. Dr. ORLANDO BOSCH AVILA is the sole Chief. The leadership and direction stems from a small group headed by BOSCH in Miami.

MM T-3 said the MIRR receives no funds and no direction from Cuba or any other foreign country. The members are responsible only to BOSCH and the other officers, all of whom live in Miami.
