Re New Orleans airtel to Bureau, 5/22/64.

Enclosed for Bureau are 12 copies of a letterhead memorandum setting forth information regarding captioned subject. Sufficient extra copies of LHM being sent New York and New Orleans for local dissemination, if considered desirable.

Copies of this LHM designated for local dissemination at Miami as follows: CIA, INS, ONI, OSI, U. S. Border Patrol, G-2, Co-ordinator of Cuban Affairs, FAA, U. S. Customs and U. S. Coast Guard.

Per New Orleans airtel lead for Miami, ACELO PEDROSO, source of information in Miami 2-353, which case had to do with a plan to bomb Cuban oil refineries in mid 1963, was contacted on 6/26/64 and advised he had no information in this matter.

MM 639-S, who is in daily contact with ANGEL VEGA of the MDC, has advised that the MDC has no military plans for use of airplanes against Cuba.
