PITTMAN indicated that he would be leaving by automobile for the West Coast by 8/1/55 and brought up the matter of financial assistance to facilitate the change. CSSF 2140-S* advised on 3/3/55 that JOHN PITTMAN would take over as editor of the "Daily People's World" when the present editor, a convicted Smith Act subject, goes to jail. INY 779-S. who has furnished reliable information in the past, advised on 3/2/55 that JOHN PITTMAN, who is temporarily "Daily Worker" city editor, was scheduled in the near future for permanent assignment on California on the "Daily People's World". The "Daily Worker" of 2/23/55, page 1, could not be the second se reflected that the editorial board of the "Daily Worker" on 2/2/55 announced that JOHN PITTMAN is taking over the duties of "Daily Worker" news editor after serving as foreign editor for several years. 
