Succinct Resume of Case

CSSF 2140-S\*, who is in a position to furnish reliable information, advised on 4/8/55 that JOHN (PITTMAN) had recently corresponded with WILLIAM SCHNEIDERMAN, Chairman of CP District 13. PITTMAN indicated that he would be leaving by automobile for the West Coast by 8/1/55 and brought up the matter of financial assistance to facilitate the change.

CSSF 2140-S\* advised on 3/3/55 that JOHN PITTMAN would take over as editor of the "Daily People's World" when the present editor, a convicted Smith Act subject, goes to jail.

(S) NY 779-S\* who has furnished reliable information in the past, advised on 3/2/55 that JOHN PITTMAN, who is temporarily "Daily Worker" city editor, was scheduled in the near future for permanent assignment on California on the staff of the "Daily People's World".

The "Daily Worker" of 2/23/55, page 1, column 1, reflected that the editorial board of the "Daily Worker", on 2/2/55 announced that JOHN PITTMAN is taking over the duties of "Daily Worker" news editor after serving as foreign editor for several years. The "Daily Worker" is an east coast Communist daily newspaper and the "Daily People's World" is a west coast Communist daily newspaper.

(S) NY 779-S\* advised on 1/22/55 that JOHN PITTMAN was reportedly in ascendancy within the leadership of the CP and had been meeting with leaders of the CP in recent months.

Former ND 610-S\* (and NY 559-S\*) who have furnished reliable information in the past, advised on 12/28/50 and 1/12/51 respectively that PITTMAN was elected to the Press Committee at the national convention of the CP, USA which was held on 12/28/50 at NYC.

PITTMAN registered in 1938 and 1939 with the Registrar of Voters, San Francisco, California, as affiliated

**SYNOPSIS OF FACTS:** JOHN PITTMAN resides at 628 W. 151st St., NYC, and is news editor of the "Daily Worker". Informant, who has furnished reliable information in the past, advised in March 1955, that PITTMAN was scheduled in the near future for permanent assignment on the staff of the "Daily People's World" in California. Informant, who is in a position to furnish accurate information, advised in April 1955, that PITTMAN planned to return to the West Coast on or about August 1, 1955. PITTMAN conducted a 12-day tour of mid-Western cities in support of the subscription drive of the "Daily Worker" and "The Worker". PITTMAN is listed in the 1955 Spring and Winter catalogs of the Jefferson School of Social Science, NYC, as an instructor.
