MARGARET ADLER PITTMAN is the wife of JOHN PITTMAN. Referenced report reflects [NY 779-S\*] advised on 3/2/55, that subject, JOHN PITTMAN, who at that time was temporarily the "Daily Worker" city editor, was scheduled in the near future for permanent assignment in California on the staff of the "Daily People's World". Referenced report further reflects that CSSF 2140-S\* advised on 4/8/55, that JOHN PITTMAN and his family plan on going to the West Coast by automobile on or about 8/1/55.

On 8/11/55, Supt. G. HILDEN, 628 West 151 Street, NYC, where JOHN PITTMAN and his wife maintain residence, advised SAS DOUGLAS L. BURAU and VINCENT J. CUNNINGHAM that JOHN PITTMAN and his family left on or about 8/1/55, and he understood from JOHN PITTMAN that they were going to California. A check of the Main Post Office, NYC, and the Hamilton Grange Station Post Office, 521 West 146 Street, NYC, disclosed no removal notice for JOHN and MARGARET PITTMAN, 628 West 151 St., NYC.

San Francisco is requested to alert informants to determine if JOHN PITTMAN and family are presently in San Francisco and ascertain present residence. NYO will submit Form 128 upon receipt of verification of residence of JOHN PITTMAN and his wife.
