- 1. SOURCE OF PARAGRAPHS 2-6: A VENEZUELAN BUSINESSMAN WHOSE ACTIVITIES BRING HIM INTO CLOSE CONTACT WITH VARIOUS GOVERNMENT OFFICIALS. HIS RELIABILITY HAS NOT BEEN ESTABLISHED. HE RECEIVED THE INFORMATION FROM SOMEONE WHO SPOKE WITH ORLANDO BOSCH:
- 2, IN MID-NOVEMBER 1976 CUBAN EXILE LEADER ORLANDO BOS CH, WHO IS CURRENTLY UNDER DETENTION IN VENEZUELA IN CONNECTION WITH THE 6 OCTOBER BOMBING OF A CUBANA AIRLINER, SAID THAT THE BOMBING OF THE PLANE IN THE AIR HAD BEEN A MISTAKE. 
