On January 8, 1964, TYRUS MINNIX, Assistant
in Charge of Travel Control, INS, Miami, advised he
talked to VIDAL that day by phone, and VIDAL is currently
in the Pan American Hospital, Miami, suffering burns on
his face. MINNIX said when he is released from the
hospital, he will be interviewed under oath by INS, but
it is unknown what action INS will take.
