On 3/23/64, LUIS RODRIGUEZ, 19924 Lindsay, Detroit, (source - protect - deemed advisable) advised SA JAMES R. MC CANCE that he has heard of an organization, which he believes is called JURE. The location of the headquarters of this organization is not known. Source continued saying that he has not been contacted and does not know how contact has been made regarding the organization. He recently heard that three persons from Detroit have contributed \$20.00 each to JURE and the purpose of the contribution is said to be for purchase of an M-1 rifle presumably to be used against CASTRO.

The three contributors are known to the source as responsible persons, who have been associated with the Cuban Michigan Association, an anti-CASTRO group of Cubans being formed in Michigan. These persons are:
