Rerep of SA JOHN L. SPURGERS, JR. dated 11/26/63 at San Juan; and Bulet dated 12/17/63.

Individual identified in rerep as Tampa, Fla. coordinator of JURE is identical with MARIO RUIZ BALBER (Protect Identity), 1818 17th Avenue, who is a PSI of the Tampa Division (Tampa file 134-299) (S)(U)

RUIZ has furnished reliable information in the past and furnishes information on a continuing basis concerning activities of JURE in the Tampa area. (S)(U)

Meetings of JURE have been held on Weds. nights at 1515 10th Avenue with approximately 12 members of the organization in attendance. PSI advises that meetings are being held for the purpose of keeping up to date on activities of JURE in Cuba and other Latin American countries. (S)(U)
