While it is recognized that the investigative period is quite expended, it is pointed out that investigative efforts of the Dallas Office were set out in part in Dallas letter to Miami, 8/12/63, and Dallas letter to San Juan, 10/8/63. It will be further noted that agent to whom this investigation is assigned has been employed full time in the investigation of LEE HARVEY OSWALD matter at Dallas since November, 1963. u
