Re Miami letter dated 9/30/74 to the Bureau.

No reports of additional "Zero" letters have been received by the Miami Office and no further evidence of an admissible nature has been developed against the suspects in this case.

MM 1550-KS, who is in frequent contact with the principal suspect LUIS TORNES, has advised that TORNES appears to be no longer active or interested in "Zero" which has become dormant. (u)

As the Bureau is aware, Miami opened a case file number 9-2690 entitled, "ZERO", (an organization), AKA; UNKNOWN SUBJECT, AKA 'Zero'; ET AL; MANOLO ARTIME BUESA - VICTIM; ET AL; EXTORTION", relative to the criminal aspects of this case.

On 11/26/74, Assistant U. S. Attorney JEROME ULLMAN declined prosecution on basis of investigation to date, subject to reopening in the event evidence of an admissible nature is obtained. Miami will submit a separate report on its file number 9-2690 reporting Mr. ULLMAN's decision.

As MM 1550-KS and MM 1337-S are still in a position to obtain further information, this case is being maintained in a pending status for a reasonable period of time.
