SP 1159-S on 9/15/59 advised that at a meeting of MARGARETE PITTMAN's CP Club on 9/14/59, after she and her family had departed, it was announced that she was on her vacation and would return the next week. A neighborhood source advised that Mrs. PITTMAN was heard to comment that she and her family would be in Europe for approximately one year but that there was no mention of the employment of JOHN PITTMAN.

If any information concerning JOHN PITTMAN's employment is obtained from any other source, the Bureau will be advised immediately.
