The foregoing information is summarized in the administrative section of this report to furnish the background concerning arrangements for the PITTMANS' trip to Moscow, inasmuch as utmost care must be utilized in handling and reporting the information from CG 5824-S* and NY 694-S*. (S)(u)

The purpose of the trip of the PITTMANS to Europe, the ultimate assignment of JOHN PITTMAN, and the source of funds financing the trip, have not been reported by any other source and dissemination of this information could well place the position of the informants in jeopardy. (S)(u)
