Re New York airtel to the Bureau dated 10/21/66.

On 10/28/66, BA 1328-PSI advised that he had no knowledge of above captioned individual but that he had been in contact with TOM BOWERS on that same date and that BOWERS had advised him that "someone who really knew what it was all about" might possibly be coming to Baltimore that weekend and that if the person did come, BOWERS would advise the informant.

On 11/4/66, the informant stated that although he had been in contact with BOWERS over the past weekend, BOWERS had said nothing about the unknown subject coming to Baltimore, Maryland.

For the information of the Bureau and New York, TOM BOWERS, a student at Johns Hopkins University (JHU), Baltimore, Maryland, has recently formed the Communist Organizing Committee (COC), a pro-Red Chinese organization, which is not affiliated with any major subversive organization.

Contacts at the University of Maryland during the past weekend failed to indicate that above captioned individual came to the university during the weekend. It is presumed that the subject did not come to Maryland during the past weekend.

On 11/4/66, BA 975-S advised that above captioned individual might be identical with an American couple who were in Moscow, USSR, during May, 1961 and who were at that time in contact with BA 975-S while in that city. BA 975-S stated that the couple, whose names were DICK and SUSAN, had a home address of 110 Christopher Street, New York, New York. The couple appeared to be in their late 30's. SUSAN was
