VERA was provided a copy of a letter directed to United Press International at Puerto Rico from a group known as M-7 but alleged no knowledge of M-7. He did stated that M-7 possibly meant Movimiento Revolucionario de Julio (Revolutionary Movement of July), July being the seventh month.

San Juan is of the opinion that M-7 may possibly be the sub-group of CU referred to by VERA but is unable to pursue this matter further with VERA a the present time to protect the identity of MM 1337-S.

San Juan anticipates continued contact with VERA regarding bombing matters. VERA admitted having received training in making bombs while in Cuba during the Cuban revolution but denied any involvement or knowledge of persons involved in the bombings of the consulates of Venezuela, Peru and Argentina at San Juan, Puerto Rico.
