Date 7-18-61 by WAL/seoEnclosed for the information of the Bureau are  
nine (9) copies of a letterhead memorandum captioned,  
CUBAN REBEL ACTIVITIES IN CUBA dated as above.NK T-1 is Retired Colonel HERBERT H. HARTMAN,  
Harvey Cedars, N.J., who has been a source of information  
for this office in the NATHAN GREGORY SILVERMASTER case.GEORGE R. DAMON was the subject of an FAG case  
in 1958 (Bufile 46-32613). DAMON also became involved in  
Cuban activities in 1958 when he was approached by pro-  
CASTRO forces to smuggle arms and men into Cuba. DAMON  
told the BATISTA Government of this approach and demanded  
money for exposing the plot. However, the BATISTA forces  
wanted him to actually run the men and guns into Cuba  
where they could be arrested but DAMON refused to do so,  
saying he would be killed.
