U.S. Customs, U.S. Border Patrol, ONI and CIA,
Miami have been contacted concerning this matter with
negative results.

CIA, Miami advise they have no operational
interest in either MENOYO or GERALD PATRICK HEMMING, do
not anticipate any in the future, and have doubts concern-
ing their motives and reliability. (S)(u)

The U.S. Coast Guard is presently in the process
of checking its records to ascertain the identities of any
boats stopped by them between August 16th and August 17,
1961. (S)(u)

The Miami Office anticipates further inquiry
into this matter and interview of MENOYO and HEMMING to
identify the participants in this mission. The enclosed
information will be subsequently submitted in report form. (S)(u)
