GERALD PATRICK HEMMING IS - CUBA.

ON MARCH 8 INSTANT MM 639S ADVISED THAT HE HAD BEEN  
IN CONTACT WITH SUBJECT IN MIAMI ON THIS DATE. HEMMING  
ADVISED THAT HE HAD JUST RETURNED FROM WASHINGTON, D. C.  
WHERE HE HAD SPENT SEVEN OR EIGHT DAYS. HE SAID WHILE IN  
WASHINGTON HE VISITED A GREAT MANY PEOPLE IN THE STATE  
DEPARTMENT AND PENTAGON. HE SAID THAT STERLING COTTRELL  
UNDER SECRETARY OF STATE FOR CUBAN AFFAIRS HELPED HIM MEET  
MANY OF THE PEOPLE. HE SAID HE BECAME PARTICULARLY FRIENDLY  
WITH A MARINE CORPS GENERAL NAME NOT KNOWN TO INFORMANT,  
WHO IS STATIONED AT THE WHITE HOUSE. (X)(u)

HE LEARNED FROM THESE PEOPLE THAT THE MOST IMPORTANT  
ITEM OF CONCERN WITH REGARD TO CUBA AT PRESENT IS THE CONTROL  
OF PERSONNEL AND MATERIAL LEAVING CUBA FOR VARIOUS LATIN  
AMERICAN COUNTRIES PRESUMABLY FOR REASONS OF SUBVERSION. (X)

HEMING SAID THAT SEVERAL TOP MILITARY AND STATE  
DEPARTMENT OFFICIALS HAD BEEN ASSIGNED TO SEEK AN ANSWER TO  
THIS PROBLEM AND THEY HAD BEEN WORKING ON IT FOR ABOUT A  
MONTH. THEIR ANSWERS TO THE PROBLEM WERE SUPPOSED TO BE ON  
PRESIDENT KENNEDY'S DESK MARCH 8 INSTANT. HEMMING SAID THAT (X)(u)
