The referenced communication instructed Miami to furnish its observations on compromising the security of MM 639-S should GERALD PATRICK HEMMING and/or JOSE ANTONIO DUARTE-OROPESA be interviewed concerning their knowledge of Students for a Democratic Society (SDS) members traveling to Mexico to receive guerrilla training.

Miami is of the opinion that such interviews, conducted with discretion, and in a manner in which the source would not be revealed, would not pose a risk to the security of MM 639-S.

HEMMING, if experience proves true, probably discussed the matter with others also. HEMMING is a former source of the Miami Office. When contacted in the past, he was amiable and appeared cooperative. The cautionary opinion expressed by MM 639-S with respect to his reliability should, however, be taken into consideration.
