Reference is made to my communication dated
November 8, 1960.

On November 3, 1960, the informant mentioned in the
referenced communication who has furnished reliable information
in the past advised that approximately ten persons planned to
make the trip to Cuba aboard the yacht to deliver equipment to
the captioned organization in the Escambray Mountains. Reportedly,
Rolando Gruart, a 17-year-old Cuban exile residing at
1538 Southwest Third Street, Miami, Florida, indicated he was
not going along because he had obtained employment in Miami.
Gruart allegedly saw the weapons which the captioned organization
planned to take to Cuba. He indicated they were in Miami, but
did not confide as to their specific location. Gruart indicated
the weapons consist of bazookas, antiaircraft guns, machine
guns, Belgian pistols and enough arms to equip a force of 100
men. Gruart reportedly stated that Victor Manuel Paneque y
Batista, who allegedly was second in command of the captioned
organization, had purchased the arms on a recent trip to
the northern part of the United States.

The informant on November 3, 1960, indicated that the
radio aboard the vessel was still inoperative, but the informant
believed that the work might be completed by an unidentified
individual which would permit the departure of the vessel over
this past week end.

The "Miami Herald," a Miami, Florida, newspaper, on August 10, 1960, carried an article indicating that a number of Castro military personnel had defected and had established a counterrevolutionary movement in Cuba known as the Movimiento Insurreccional de Recuperacion Revolucionaria (MIRR). Dr. Orlando Bosch Avila, former Chief of the July 26 Movement in Las Villas Province, Cuba, was named as the MIRR delegate in exile in Miami. Bosch claimed that the MIRR is the strongest anti-Castro movement in Cuba. Victor Manuel Paneque y Batista, a former Major in the Cuban Revolutionary Army who is presently in Miami, allegedly is second in command of the MIRR.

On November 1, 1960, an informant who has furnished reliable information in the past advised that Bosch possesses a 40-foot yacht named "Trudy Lou," bearing Registration Number FL-6705. Reportedly, this yacht was docked at Just Island in the Miami River and was being outfitted with a two-way short-wave radio. Reportedly, the vessel is scheduled to make a clandestine trip to Cuba for the purpose of bringing equipment to the captioned organization in the Escambray Mountains of Cuba.

On November 2, 1960, the informant reported that the above-mentioned equipment will include a two-way portable radio. The informant suspects that small arms may also be transported and that about four men possibly will make the trip.

According to information provided by the informant, the vessel is scheduled to depart in the immediate future, possibly under the command of Paneque. Bosch has also reportedly acquired a radio transmitter and receiver which operates on 4895 kilocycles, which is allegedly located at his residence at 4138 Southwest 16th Terrace. All of the above-mentioned radio equipment operates on the same frequency.

Several sources consider Paneque suspicious because of unverified rumors circulating in the Miami area to the effect that he is a Castro agent. Paneque was interviewed on October 12, 1960. He claimed to be anti-Castro and anticommunist and that he came to the United States for the purpose of organizing and soliciting aid for the captioned organization. He claimed that he had recently visited the Pentagon in Washington, D. C., where he contacted two unidentified individuals in the Department of the Navy relative to a plan for aiding anti-Castro forces in Cuba. Paneque stated he had served as Chief of Public Order, G-3, Cuban Army, from July, 1959, to September 1, 1960, when he stole a boat and left Cuba.
