Enclosed herewith for the Bureau information is one mimeographed copy of a seven-page, legal-sized document in the Spanish language. This document was furnished to SA HOWARD F. WINTER on 10/18/61 by WFO confidential source, RAMIRO LOYS.

LOYS said that this enclosure is a copy of the original document presented on 10/5/61 by Dr. LOUIS CONTE AGUERO, President of the Cuban Anti-Castro Exile Organizations "Frente Anticomunista Cristiano" (the English translation of which is Anti-Communist Christian Front) and "Alianza de la Libertad" (Alliance for Liberty) to the Inter-American Commission on Human Rights of the Organization of American States (OAS), Pan American Union Building, 19th Street and Constitution Avenue, NW, Washington, D.C. LOYS said that CONTE AGUERO was accompanied during his presentation of the document by one Dr. PINTADO, Cuban exile from the Miami area who is not otherwise known to LOYS.

It is noted that the enclosed document contains a vigorous protest against the executions of Cubans in Cuba by the CASTRO regime. In addition, it contains a lengthy list of names of individual Cubans who have allegedly been executed by the CASTRO regime through 10/15/60.

Liaison, with the special investigating squad of the Metropolitan Police Department, Washington, D.C., has produced no further pertinent information concerning this matter.
