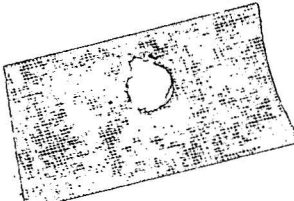

Re Miami letter to Bureau, 4/27/62.

The Christian Anti-Communist Front (CACF) formerly maintained an office in the NY area at the San Rafael Hotel but this office has been closed for many months due to inactivity, and the fact that the head of the CACF, LUIS CONTE AGUERO, has been residing in Miami, Florida.

Dr. ERNESTO ARAGON, secretary to Dr. JOSE MIRO CARDONA, President of the Cuban Revolutionary Council (CRC), advised on May 10, 1962, that the CACF is no longer active in the NY area and whatever activity there is in this organization is centered in the Miami, Florida, area.

ARAGON further advised on 5/10/62, that as he previously related, CONTE AGUERO left the CRC in February, 1962, shortly after the Foreign Ministers Meeting held in Punta del Este, Uruguay, during late January, 1962. ARAGON stated that in various countries in which CONTE AGUERO went prior to arriving in Uruguay, he created scandals because of his personal escapades and was instructed to return directly to Miami after his speech in Montevideo, Uruguay.
