The 10/59 Michigan State University (MSU), East Lansing, Michigan Student Directory lists RONALD P. PHIPPS, Student Number 190390, as residing East Shaw Hall. His home residence is listed as 1095 Linden Street, Valley Stream, New York. The 10/60 Directory lists him at 211 M.A.C., East Lansing; 10/61 Directory contains no local address; 10/62 Directory lists him at 618 Forest Street, East Lansing; 10/63 Directory lists him at 1425 A Spartan Village, East Lansing; 11/65 Directory lists him at 911 East Cherry Lane; and the 11/66 Directory lists him at 911 East Cherry Lane.

CSDE 1048, who has furnished reliable information in the past, advised that RONALD P. PHIPPS enrolled at Michigan State University (MSU) on 9/22/59 and graduated in the fall of 1964. In 1965 and 1966 he was a graduate student at MSU in the Department of Philosophy. His wife, RITA PHIPPS, Student Number 180248, is listed as being at MSU in 1/59. Her next of kin is listed as WILLIAM BURNEY, 608 Cherry Lane, East Lansing.
