On 5/5/70, IC RAYMOND A. LANGLOIS determined through contact with CSSF 50-X that this telephone number was listed to MICHAEL VAWTER, 782 Hampshire Street, San Francisco, California, This service was established in 6/69 and is a non-published No other additional listings were noted for VAWTER.

MICHAEL VAWTER of 782 Hampshire Street, San Francisco, California, is identical to MICHAEL DAVID VAWTER (Bureau File 105-187484; SF File 100-61293), a Security Index, Priority I, Subject of the San Francisco Office. MICHAEL VAWTER and his wife, JANET VAWTER (Bureau File 105-189249; SF File 100-61509), are members of the Bay Area Revolutionary Union (RU), a militant pro-Chicom new left organization in the San Francisco Bay area, concerning which information has previously been furnished the New York Office. It is being pointed out that the caution statément that MICHAEL DAVID VAWTER "MAY BE ARMED AND SHOULD BE CONSIDERED DANGEROUS" was utilized in the last annual San Francisco report concerning VAWTER dated 11/5/69 based upon VAWTER's participation in firearms practice and the interest in weapons expressed by members of the RU.

MICHAEL VAWTER is a white, male, American, born 11/28/47 at San Francisco, California. He was a former student at Stanford University, Department of English, Palo Alto.
