he, like other Cuban refugees, applied for refugee status with the INS, Miami, Florida, about August 8, 1969, and his request is presently being processed.

JOSE VALDES advised that he is certain that ARMANDO GUERRA is not a security risk to the U.S. and that he is anti-Castro and anti-Communist. GUERRA appreciates the U.S. and is very happy to be residing in this country. JOSE VALDES stated he had no knowledge of and no information concerning any anti-Castro attitude on the part of ARMANDO GUERRA.

Efforts have been made since September 11, 1969, to obtain the INS file of ARMANDO GUERRA. The file was charged to the Travel Control Section where his refugee status is being processed. However, to date, INS has been unable to locate the file.
