To date, no information has been developed as to the whereabouts of other boats of the SNFE in the Miami area, except the small speedboat on which GUTIERREZ MENOYO was returned to Miami. U. S. Customs will be contacted and arrangements made to examine this boat. During interview, GUTIERREZ made mention of the fact that this boat had no name, was not registered, and that he was unable to understand by what right he had been seized by the Coast Guard in international waters. This is pointed out as it may be difficult to ascertain the origin of ownership of this boat.

SANFORD CLOSE, owner of the building in which the SNFE office is located, has been contacted with regard to feasibility of a trash cover on this office and the Bureau will be advised of the outcome of this matter
