MM 761-S advised this date that he was able to purchase the book "Cardiovascular Surgery" requested by ROLANDO CUBELA in his letter to CARLOS TEPEDINO. The book is to be delivered to TEPEDINO's office probably today and upon receipt, source will contact OSCAR GUTIERREZ and arrange to deliver it personally to either GUTIERREZ or MARTA JIMENEZ at the Cuban Mission to the UN. He feels confident that either through GUTIERREZ or JUAN DUARBE, a long time acquaintance, he will be able to arrange to see ROA. (S)(u)

The problem to date has been that ROA, as the Bureau is aware, is staying at the residence of FERNANDO TABIO, and because of the newspaper strike in New York City, little or no publicity has been given to ROA's presence here. Spot checks on the CMUN and established sources have indicated that ROA has not spent much time at the CMUN since his arrival. Nevertheless, it is believed that the source, who is unaware of ROA's whereabouts, should consign and direct his efforts to see ROA through the CMUN. Any attempt for the source to contact ROA at his residence would, the NYO believes, arouse suspicion on the part of ROA concerning the motives of the source. (S)(u)
