Enclosed herewith are 11 copies of letterhead
memorandum dated and captioned as above.

Copies of this memorandum are being furnished
to CIA, INS, U.S. Border Patrol, U.S. Coast Guard and
U.S. Customs at Miami.

The source mentioned in memo, who furnished
the DRE handbill is MM 847-S.

In view of the fact investigation has resulted
negatively in developing any specific details or evidence
of the military action which, according to information
previously received from CIA, was to be carried out by
the DRE as of March 14, 1963, and in view of the fact that
the leaders of the DRE have stated any plans for such
future action from the United States are suspended be-
cause of recent U.S. policy activation, investigation is
being terminated. The Miami Office intends to maintain
contact with elements of the DRE so that any indication
of future plans may become known to the Miami Office be-
fore action is taken. In the event information is thus
developed that the DRE is planning an operation, the
Bureau and appropriate government agencies at Miami will
