JAMES PERRY DOWRICK, according to Miami Office indices, was carried by the Miami Office as a PSI under development, Miami file 134-383. Indices failed to reflect any other references for DOWRICK. (S) (X) (u)

MATTHEW DUKE, according to Miami Office indices, was a subject of a Bureau investigation captioned "MATTHEW EDWARD DUKE, aka; POLICE COOPERATION - FOREIGN MISCELLANEOUS", Bufile 64-43934, Miami file 64-178. Bureau is advised that the U. S. Border Patrol and U. S. Customs, both Miami, Florida, have been furnished all information in possession of the Miami Office relating to DUKE and his activities.

MICHAEL DE CANDIO, JR., in contact, advised that there is no G-2, as such, in the Miami area, and that Counter Intelligence Corps, Miami, is performing some of the duties that would normally be performed by G-2, pending the establishment of a G-2 in Miami.

The CIA source referred to in the details of this report under MM T-3, is one of the subjects in instant case, identified by CIA, Miami, as PAUL JOSEPH HUGHES. The CIA representative in Miami stated that he did not press HUGHES on his contact with him on February 4, 1960, for further details, inasmuch as CIA has no jurisdiction over instant matter, explaining that CIA is only interested in affairs affecting the external security of the United States. During the interview with subject MATTHEW DUKE, February 19, 1960, DUKE advised that he had furnished information to CIA in both Washington, DC and New York City. He identified the Washington, DC CIA Agent as named O'CONNELL, and the New York CIA Agent as Mr. FRANK. DUKE claimed to have furnished information to the CIA Agents in October, 1959. (S)(U)

On February 17, 1960, CIA advised it has not had and does not currently have any operational interest whatsoever in the subject or MATTHEW DUKE. CIA claimed that neither of these individuals has been receiving any guidance, support or compensation from CIA. CIA stated that any statements made by HUGHES or his associates that they are performing duties on behalf of CIA, are absolutely false. CIA stated that HUGHES has volunteered information to CIA, and that this data has been disseminated to interested agencies and the Bureau. CIA considers HUGHES to be unreliable. (S)(U)

Colonel STEWART MC KENNEY, Chief, Operations Branch, Assistant Chief of Staff for Intelligence, advised HUGHES is not an informant of the Army. He was contacted in December, 1959, by Army after he had advised G-2 in Atlanta that he had information of interest to the Army. The only other Army contact with HUGHES was the information which the Army furnished us on February 9, 1960. *REMAIN UNCLASSIFIED BY 28 Army 107 STD 8-28-81 SP-6 RTH/jm 9-25-81*
