Reference is made to your letter dated March 16, 1965, requesting advice regarding certain confidential informants in the report of Special Agent Wilbert H. Kehe dated September 23, 1964, at San Francisco, California, regarding John Orion Pittman.

The symbols T-2, T-4, and T-5 in the report of Special Agent Kehe relate to confidential informants who have been identified to the Department under the alphabetical designations 5K (San Francisco), 5'1' (San Francisco), and 9Z (San Francisco), respectively. The symbol T-6 relates to Henry Oscar Mariott, a former confidential informant of this Bureau's San Francisco Office who has been released to testify at the forthcoming retrial of the Communist Party, USA, for failure to register under the Internal Security Act of 1950.
