

ADMINISTRATIVE DATA:

On 8/18/64, CG 5824-S furnished information concerning a letter addressed by JOHN PITTMAN to the National Review Commission of the CPUSA, dated 2/7/46. This letter furnished an autobiography on PITTMAN which sets forth the fact that he had joined the Communist Party in Berkeley, California in 1935, that he had served as the organizer of the campus branch, as a member of the San Francisco County Committee and Executive Board, and as a member of the Communist Party State Committee.

By letter dated 12/11/64, Chicago instructed that this information must not be disseminated outside the Bureau and must be confined to the administrative pages because it originated from an extremely delicate source.
